Sir,

I am directed by order of the Governor to state that in view of all round increase in operational cost of G.R. cereals in this State due to price hike of diesel and difficulties faced by the Storing Agents/G.R. Distributions/G.R. Dealers in transporting foodgrains for G.R. Distribution System, it has become necessary to enhance and also to rationalise transport rebate allowed to Storing Agents/G.R. Distributors/G.R. Dealers.

The Governor is, therefore, in supersession of all G.O.s issued earlier in this respect for all M.R., S.R., riverine areas of North & South 24-Parganas, Hill areas of Darjeeling District and areas within Purba Medinipur & Paschim Medinipur, Uttar Dinajpur & Dakshin Dinajpur Districts, Pleased to allow the Transport Rebate at the following rates to the above mentioned distributors/storing agents/dealers of aforesaid areas of West Bengal with effect from the date of issue of this orders :-

- I. For all areas of M.R. & S.R. other than riverine areas, areas of North & South 24-Parganas, areas within Purba Medinipur, Paschim Medinipur, Uttar Dinajpur & Dakshin Dinajpur Districts and Hill areas of Darjeeling District.
- a) For any distance upto first 8 Kms. from feeder godowns. :- Rs. 10.60 (Rupees ten) per qtl.
 - b) For any distance beyond 8 Kms. from feeder godown upto 40 kms. :- @ 00.63p. per qtl. per Km. subject to a maximum of Rs. 22.60 (Rupees twenty two & sixty paise) only per qtl. including the basic rate of Rs. 10.00 per qtl.
 - c) For any distance beyond 40 Km. from feeder godowns upto 60 Kms. :- @ 00.25p. per qtl. per kms. subject to a maximum of Rs. 25.10 (Rupees twenty five & paise ten) only per qtl. including Rs. 22.60p. for first 40 kms.
 - d) For any distance beyond 60 kms. from feeder godowns upto 120 Kms. :- @ 00.17p. per qtl. per km. subject to a maximum of Rs. 35.30p. (Rupees thirty five and paise thirty) only per qtl. including Rs. 25.10p. for first 60 Kms.
 - e) For any distance beyond 120 Kms. from feeder godowns. :- @ 00.13p. per qtl. per Km. in addition to Rs. 35.30p. (Rupees thirty five & paise thirty) only for the first 120 Kms.

II. Riverine areas of North & South 24-Parganas involving Transshipment.

- a) For any distance upto 8 Kms. from feeder godowns. :- Rs. 18.80p. (Rupees eighteen & paise eighty) only (Rs. 10.00 + 8.80) for transshipment per qtl.

- b) For distance beyond 8 Kms. :-
The rates laid down in sub para (b), (c), (d) & (e) of para-I above shall be applicable in addition to Rs. 8.80p. per qtl. for transhipment.

III. Hill areas of Darjeeling District.

- a) For any distance upto 10 Kms. :- Rs.10.44p.(Rupees ten & forty four paise) only per qtl. from feeder godowns.
- b) For any distance beyond the first 10 Kms. from feeder godowns. :- @ Rs.1.15p.(Rupees one & fifteen paise) only per qtl. per Km. in addition to Rs.10.44p. for the first 10 Kms..

IV. Areas within Midnapore, Uttar Dinajpur & Dakshin Dinajpur.

- a) For any distance upto 8 Kms. :- Rs.10.00(Rupees ten) only per qtl. from feeder godowns
- b) For any distance beyond the first 8 Kms. from feeder godowns upto a distance of 60 Kms. :- @ 00.63 paise per qtl. per Km. subject to a maximum of Rs.25.75p.(Rupees twenty five & seventy five paise) only per qtl. including the basic rate of Rs.10.00 per qtl. for the first 8 Kms.
- c) For any distance beyond 60 Kms. from feeder godown upto 120 Kms. :- @ 00.17p. per qtl. per Km. subject to a maximum of Rs.35.95p (Rupees thirty five & ninety five paise) only including the basic rate of Rs.25.75p. for the first 60 Km.
- d) For any distance beyond 120 Km. from feeder godown. :- @ 00.10p. per qtl. per Km. in addition to Rs.35.95p. per qtl. for the first 120 Kms.
