
Sir,

In cancellation of this Deptt. G.O.No.2011(40)-FR/8C-01/04, dt.03.11.08, I am directed to state that the Governor has been pleased to increase the number of members of the joint inspecting team constituted under G.O. No.2591(40)-FR/7M-79 by 2000 dt. the 2<sup>nd</sup> October, 2000 from the existing three to four in the following manner :-

- 1) One representative of the Panchayat Samiti,
- 2) One representative of the Block Development Officer,
- 3) One representative of the concerned Gram Panchayat and
- 4) Leader of the Opposition of that Gram Panchayat or an Ex-Officio Member from the Opposition Party (elected member of the Panchayat Samiti from the concerned Gram Panchayat) or one independent elected member of the concerned Gram Panchayat in absence of any elected member from the Opposition Party.

All other contents of this Deptt.'s G.O. No.2591(40)-FR/7M-79 by 2000 dt. the 2<sup>nd</sup> October, 2008 will remain unchanged except the above constitution of the joint inspecting team in rural areas.
