Sub.: Rates of carrying charges/transport
revenue admissible to the G.R./F.I.W./
D.J./E.G.W. Dealers/Distributors/Storing
Agents.

Sir,
In supersession of this Department's previous Order bearing
No. 2050(17)-F.R. dated 14.08.97 on the above subject, I am directed
by Order of the Governor to say that the Governor has been pleased to
allow transport charges/revenue for movement of G.M. foodgrains from
all delivery points in different P.C.T./Food & Supplies Department's delivery points in different
districts, at the following rates to the G.R. dealers/distributors/
storing agents of all areas of West Bengal other than the districts of
Midnapore, Uttar Dinajpur and Dakshin Dinajpur, hilly areas of
Jalpaiguri and riverine areas of North and South 24-Parganas districts,
with immediate effect -

- a) For any distance upto First 0 kms. from funder godown -
Rs. 7.80 per quintal;
- b) For any distance beyond first 0 kms. from funder godown upto
40 Kms. 4 paisa/- per Km. per quintal subject to a maximum of
Rs. 17.40 per quintal including the basic rate of Rs. 7.80 per
quintal.
- c) For any distance between 40 Kms. and 60 Kms. - 18 paisa/- per
quintal per Km. subject to maximum of Rs. 19.20 per quintal
including Rs. 17.40 per quintal for first 40 Kms.
- d) For any distance between 60 Kms. and 120 Kms. - 12 paisa/- per
quintal per Km. subject to a maximum of Rs. 26.40 per quintal
including Rs. 19.20 per quintal for first 60 Kms.
- e) For any distance beyond 120 Kms. 6 paisa/- per quintal per Km.
in addition to Rs. 26.40 per quintal for first 120 Kms.

For the districts of Midnapore, Uttar Dinajpur and Dakshin
Dinajpur and riverine areas of North 24-Parganas and South 24-Parganas
- transport charge/revenue will be allowed at the rate of Rs. 7.80 per
quintal.

quintal for any distance upto first 0 Kms. from Funder godown and (P.M.) at the rate of 48 paisa per quintal per Km. subject to a maximum of Rs. 22.20 per quintal for any distance beyond first 8 Kms. upto 60 Kms. and (Plus) at the rate of 12 paisa per quintal per Km. for distance beyond 60 Kms. and upto 120 Kms. subject to a maximum of Rs. 29.40 including Rs. 22.20 per quintal for first 60 Kms. and (Plus) tax distance beyond first 120 Kms. at the rate of 6 paisa per quintal per Km. in addition to Rs. 29.40 per quintal for first 120 Kms.

For the riverine areas of North and South 24-Parganas, a transhipment charge at the rate of Rs. 5.00 per quintal will be allowed in addition to the foregoing rates for different stages of distance.

3. For hilly areas of Darjeeling district, transport charge/route will be allowed at the rate of 75 paisa per quintal per Km. for transport by Jeep/Hand Rowlay, Pack/pony and Hand Load or at the rate of 75 paisa per quintal per Km. for transport by Truck. In view of the peculiar climate and difficulty in communication in hilly areas a loading and unloading charge at the rate of Rs. 1/- per quintal is also allowed to the authorized G.R. dealers of hilly areas of Darjeeling District.

The rates of allowances for other items like remuneration and handling loss will remain the same as indicated in G.O. No. 6741(16)ER dt. 20.11.91 until further Orders.

5. Provision for allowing the above rates of transport charges/route separately to both the G.R. dealers/storing agents and the G.R. dealers, in cases where G.R. goods/consignment carried by both the G.R. distributors/storing agents and the G.R. dealers during its movement from the funder godown to the grass-root distribution point, remains unchanged.
